#### **OPEN LETTER**

Dear ALL,

In response to the allegations and complaints made against Athletics Federation of India from last few days by a section of media, officials and some fans on the social media, I would like to inform you that:

- 1) The selection committee for selecting the Indian team for IAAF World Championships to be held in London from 4-13 August 2017 met at 3pm in AFI headquarters on 20 July 2017 under the Chairmanship of Shri G. S. Randhawa (Olympian& Arjuna Awardee). The other members of selection committee (a list of which is on the AFI website) present during the meeting included- Shri Paramjit Singh (Member, Olympian), Shri Praveen Jolly (Member, Asia Medalist) and Shri Uday Prabhu (Member, Asian Medalist), Mrs. P. T. Usha (Govt. Observer & Coach, Olympian, Padma Sri), Shri J. S. Saini (Dronachary) and Radhakrishnan Nair ( Dy Chief Coach, special invitee), Shri Bahadur Singh (Chief coach of India, Olympian, Padma Sri, Dronachary, Asian Gold Medalist), Shri C. K. Valson (Secretary AFI,) and myself, Adille J Sumariwalla (President AFI, Olympian).
- 2) The selection committee of AFI is responsible for selection of national team for all the national and international competitions. The members of selection committee including its chairman are eminent sports personalities with strong a athletics background, unquestionable integrity and great understanding of their sport with years of experience in both coaching and selection of Indian team.
- 3) While picking the Indian team for the worlds, the selection committee was unanimous in its decision. The selection committee discussed all issues and names of all the potential athletes who it considered worthy of discussion for World Championships berth before announcing the final team which includes 24-athletes (including 14 men and 10 women athletes) and support staff.

- 4) Further, I would like to inform you that on 10<sup>th</sup> July 2017, soon after the felicitation ceremony of Indian medal winners at AAC2017 by Odisha CM Shri Naveen Patnaik at Hotel Swosti Premium, the Indian contingent was addressed (in the presence of media personnel who attended the ceremony) by CK Valson- Secretary AFI, Chief Coach Shri Bahadur Singh and deputy chief coach RK Nair. All athletes were informed by Secretary AFI that "they must participate in the Inter State Championships in Guntur (15-18 July, 2017) and if they do not perform close to the IAAF Qualifying standards, they will not be considered by the selection committee for the selection for the World Championships." AFI also sent a Press Release with quotes from Mr. Valson regarding the same on 14<sup>th</sup> July 2017, a day before the start of the Inter State Championships. - 5) As per the various media reports and complaints received on emails over the past few days after the declaration of the Indian team, questions has been raised on-
  - A) Exclusion of these three athletes- 1. PU Chitra (1500m, W), 2. Ajay Kumar Saroj (1500m, M) and 3. Sudha Singh (3000m SC, W)
  - B) And inclusion of these two athletes- 1. G Lakshmanan (5000m & 10000m, M) and 2. Swapna Barman (Hepthalon, W)

In this regard, I request you to study the comparative performance data which was discussed in detail by the committee while finalizing the Indian team, as below:

### 6) Coaches and Officials Quota:

As reported in some newspapers, websites and debated on the social media, that officials and coaches are being sent to the Worlds in place of athletes, is completely baseless allegation and without proper knowledge of the Rules and Regulations of the competition-

- 1) As per the IAAF World Championships accommodation policy, the quota of coaches is 80% of the numbers of athletes from each Federation. If the number of participating athletes from a Federation increases, the quota of team officials will also increase. (Copy enclosed). Hence, it is completely wrong to say that athletes were not selected in order to accommodate officials.
- 2) All the athletes participating in the IAAF Worlds receive free accommodation& travel by Organizing Committee (irrespective of numbers), hence, no official (s) may take their place or eat into their free quota.
- 3) Athletics Federation of India is sending only 50% coaches though 80% of officials are eligible to receive accommodation on subsidized rates.

The price in USD will be agreed subject to the prevailing exchange rate on the day the Team Accreditation Centre opens.

The accommodation invoices will be based on the information (number of persons and arrival/departure details) provided in the Final Entries, with a tolerance of two persons.

Member Federations will be expected to settle all the extra accommodation costs not covered by the LOC upon arrival in London, during the accreditation procedure. In most cases these extra costs shall be for:

- accommodation of officials
- single room occupancy
- accommodation outside the official period
- special arrangements requested to the LOC

In those cases in which the Member Federation has been authorised to purchase its own tickets and the IAAF needs to refund the corresponding cost, the amount to be refunded will normally be used to cover all or part of the extra accommodation costs. However, if the amount is insufficient, or if the travel arrangements have been made by the IAAF, the extra accommodation costs must be paid for by the Member Federation directly.

The most common payment methods will be accepted: cash, major credit cards and advance bank transfers.

IAAF WORLD CHAMPIONSHIPS LONDON, GBR 4 – 13 August 2017



#### QUALIFICATION SYSTEM AND ENTRY STANDARDS

(As approved by the IAAF Council in March and November 2016)

#### **QUALIFICATION PRINCIPLES**

#### Age Categories

Under 20 Athletes

Athletes aged 18 or 19 years on 31 December 2017, (i.e. born in 1999 or 1998), may compete in any event except the Marathon and 50km Race Walk.

Under 18 Athletes

Athletes aged 16 or 17 years on 31 December 2017 (born in 2001 or 2000), may compete in any event except the throwing events, the Combined Events, 10,000m, Marathon and the Race Walks.

Athletes younger than 16

No athlete younger than 16 years of age on 31 December 2017 (born in 2002 or later) may be entered.

#### Individual Athletes

Individual Athletes can qualify in one of four ways:

- Automatically by achieving the Entry Standard within the qualification period in accordance with criteria decided by IAAF
- Based on the finishing position at designated competitions as follows (in these cases the athletes shall also be considered as having achieved the Entry Standard):
  - The Area Champions in all the individual events (except for the Marathons). However, in the case of field events, the entry will be subject to the approval of the Technical Delegates. The Member Federation of the Area Champion will have the ultimate authority to enter the athlete or not, based on its own selection criteria.
  - For the 10,000m, the top 15 athletes finishing in the senior Men's and Women's races at the IAAF World Cross Country Championships Kampala 2017.
  - For the Combined Events, the top three in the 2016 Men's and Women's IAAF Combined Events Challenge.
  - For the 20km Race Walk, the top three in the 2016 Men's and Women's IAAF World Race Walking Challenge.
