TERMS AND CONDITIONS FOR SUPPLY OF SPORTS EQUIPMENT& PHYSIOTHERAPY EQUIPMENT

- 1. Sealed Tenders are invited by Athletics Federation of India from manufacturers/Suppliers/dealers for supply of sports equipment/physiotherapy equipments per the List mentioned below in "A" & "B"
- 2. Equipment which are used in Training should be as per rules of the World Athletics/Athletics Federation of India. The bidders should having minimum annual turn-over of Rs 50.00 lacs (Rupees fifty lacs only) from Sports equipment/physiotherapy equipment as per auditing accounts in any of the last three financial years.
- 3. The equipment to be supplied to Athletics Federation of India for different training centres the location will be intimated to the successful bidder and such successful bidder will have to supply the equipment at the location given by AFI.
- 4. The word "Tender for supply of sports equipment should be super scribed on the top left corner of the envelope bearing the name & address of the tenderer.
- 5. The sealed tender should contain the following three separately sealed envelope:- Envelope "A": EMD Rs 50000/- (Rupees fifty thousand only) to be submitted in the form of Bank Demand Draft in favour of Athletics Federation of India payable at New Delhi.
- 6. Tenders with cheque(s) will be rejected.
- 7. Envelope "B" Tender document, complete in all respects duly signed along with all supporting documents and as per proforma.
- 8. Envelope "C" Rates to be quoted in Financial Bid as per List /Brand Name attached with the Tender Document.
- 9. The Tender shall be submitted by 5.00PM till 9th February 2021 at AFI Office and will be kept in a sealed box.
- 10. The tenders received without the above will be summarily rejected.
- 11. The tentative/approximate requirement is at Annexure "A" & "B" below.
- 12. Interest free security money equivalent to 10% of the total value of the supply order will be deposited by the successful bidder, within seven days of award of supply order. The same will be refunded after successful delivery of Sports equipment/physiotherapy equipment by the bidder.
- 13. The EMD will be refunded after finalization of tender in respect of Unsuccessful bidder.
- 14. Security Money will be refunded within 30 days on completion of all contractual obligations.
- 15. Technical specification of the sports equipment/Physiotherapy equipment used in training should be as per rule of the WA/AFI.
- 16. Material indented for shall be supplied as per specifications, in full quantity within stipulated time and at place indicated in the supply order. In case of non- compliance in any of the above or any other complaint, AFI reserves the right to reject the supply or may take any other action as deemed fit including legal action. In case of any other defect etc then the penalty of 10% of total price of the supply order in addition to refund for returned / rejected goods, will become payable to AFI.
- 17. AFI will be legally competent to cancel the supply order and also to take any other action against the supplier including imposing any penalty during or till the final execution of the supply.
- 18. The supplies received, if not found as per specification of tendered items, are liable to be rejected.
- 19. If the equipment (s) is (are) found to be defective in material, size, quality or any other defect of specification or manufacturing defect, then the penalty of 10% of total price of the sports equipment will be imposed.
- 20. The warranty period of the equipment should be for a minimum period of one year.

- 21. Supply will be made in full quantity within the stipulated time and at place indicated in the supply order.
- 22. Where ever applicable specially in Physiotherapy Items AMC Contract has to be bring in force.
- 23. Vendors can submit BID for either "A", "B" or Both with same tender conditions.
- 24. Rates should be valid for 180 Days from the Date of Work Order. No escalation in price on any account will be acceptable.
- 25. After Sales service/Product Guarantee/Warrantee **MUST** be mentioned in the quotation of all Electrical/Electronics/Mechanical Items. It is desired for minimum 2 years warrantee and free service for all Electrical/Electronics/Mechanical Items.
