Subject:- Participation of Ultra Runners in the 24 HOUR IAU ASIA OCEANIA CHAMPIONSHIPS 5th&6thAPRIL 2024 – CANBERRA, AUSTRALIA

The AFI proposes to send a team comprising up to 6 men and 6 women meeting the AFI set qualification standards for the 24-Hour IAU Asia Oceania Championships to be held on 05 - 06April 2024 at Canberra, Australia. The detailed guidelines/ instructions/ eligibility criteria for selection and participation of ultra runners are placed as Annexure 'A' to this letter. Interested ultra runners, meeting selection criteria, **may apply online through the link which will be available on the AFI website from 14December 2023 to 31 December 2023 (1700 h IST)**. Requests to accept applications beyond the stipulated date and time will not be entertained. The details required to be filled in the online form is placed as Annexure 'B' of this letter.

AFI is only facilitating the participation of Indian Ultra Runners who meet qualification levels. The participation is **Athlete Funded** and **selected athletes will have to bear all expenses** of training, travel, boarding and lodging and any other related expenses.

INVITATION OF APPLICATIONS

Introduction

1. '2024 IAU 24 Hour Asia Oceania Championships', is to be held on 5th–6thApril2024 at Canberra, Australia. This is an International Association of Ultrarunners (IAU) Competition.

The Course

2. The course will be a standard 400 m stadium track

Selection Criteria

3. Race Specific Benchmark. The race specific benchmark and qualifying period mentioned therein is as given in the table below:

(a)	24 Hour Race	M	210 Km	05April 2023 to 31 December 2023
(b)	24 Hour Race	F	180 Km	05April 2023 to 31 December 2023

4. Selection Process

(a) Only Indian Citizens will be considered and the athlete must be holding a valid Indian passport.

(b) Qualifying period. As specified in the table above at para 3.

(c) Race Results. The results of the races run by the athlete must be available on the website of the organizer as on the date of submission of the application. Results, which are made available after the last date for submission of the application, may not be considered.

(d) Proof of Fitness. The athlete must have run a 12 hour or 100 Km in the anytime from 01 June 2023 to 31 December 2023. If the Race Specific Benchmark has been achieved more than four months before the last date of submission of application i.e. 31 December 2023, the athletes will be required to provide a proof of fitness. If not available, the athlete may not be considered for the selection process solely on the basis of having met the Race Specific Benchmarks and Qualifying Period. Races and timings / distances which will be considered as proof of fitness are as given next:

(i) 100 Km Race : Men 10 h; Women 13 h

(ii) 12 Hour Race : Men 115 Km; Women 90 Km

(e) Team Composition. Up to 06 Men and 06 Women, meeting the standards set by AFI could be selected to represent India.

(f) Selection Trails. No selection trials are envisaged for the Championships. However, if there is a tie between athletes meeting the criteria, the selection of the athlete would be solely at the discretion of the selection committee.

5. **Participation in races after selection.** Once selected for the races mentioned in this document, the restrictions given below will be applicable. Athletes are not permitted to participate in races/ sporting tournaments without explicit permission of the selection committee.

(a) less than 02 months from the date of Championships races longer than 12 hours /100 km are not permitted.

(b) less than 01 month from date of Championships, races longer than 21 k are not permitted.

(c) less than 15 days from date of Championships, racing / participation in any sporting event is not permitted.

6. **Expenditure for participation.** The Championships is an athlete funded events. All expenditure towards the participation is to be borne by individual athletes. If the Championship attracts a sponsor, in which the travel and accommodation is either fully or largely paid by the sponsor, then the athlete would be required to abide by certain conditions laid down by the AFI to meet the requirements of the sponsor. Details would be intimated at the appropriate stage.

7. **Announcement of Results.** Selected athletes will be intimated by e-mail and result of the selection will be posted on the official website of AFI- www.indianathletics.in by 10 January 2024.

8. **Training Camp** All athletes will need to attend a training camp of 15 days duration as intimated by AFI at the appropriate time before the championships

9. **Additional Information.**

(a) The AFI Ultra Running Committee may be contacted at ultramarathon@indianathletics.in

(b) **Training.** Athletes selected will be responsible for their own training in consultation with the Ultra-Running Committee of the AFI.

(c) **Injuries sustained prior to the Championships.** If a selected athlete gets injured during the preparation before the event, and his participation in the event is at risk, he / she must inform the Ultra-Running Committee of the AFI at the earliest.
